In consideration of the services of ARAMARK, their officers, agents, employees and stockholders, and all other persons or entities associated with those businesses (hereinafter collectively referred to as "WILDERNESS RIVER ADVENTURES, INC."), I agree as follows:

Although WILDERNESS RIVER ADVENTURES, INC. has taken reasonable steps to provide me with appropriate equipment and/or skilled guides so you can enjoy an activity for which I may not be skilled, Wilderness River Adventures has informed me that this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of this activity. These inherent risks are some of the same elements that contribute to the unique character of this activity and can be cause of loss or damage to your equipment, accidental injury, and illness or in extreme cases, permanent trauma or death. Wilderness River Adventures does not want to frighten me or reduce my enthusiasm for this activity, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all of those risks.

- a. Heat related risks (i.e., sunburn, heat exhaustion, dehydration, heat stroke, disorientation, and hyponatremia)
- b. Falls / cuts / bruises / infections / broken bones / sprains / dislocations/ allergic reactions or other ailments caused by whitewater activities or hiking or swimming, etc.
- c. Water related accidents including but not limited to: drowning, hypothermia, loss of life or other
- d. Loss of or damage to personal equipment due to river running conditions or wilderness area camping situations or flash floods
- e. Travel delays due to motor or equipment problems, natural disasters or adverse weather situations
- f. Evacuation delays due to remoteness of area or other circumstances beyond our control
- g. Etc.

I am aware that white water rafting entails risks of injury or death to any participant. I understand that the description of these inherent risks is not complete, and that other unknown or unanticipated inherent risks may result in injury or death. I agree to assume responsibility and accept full responsibility for the inherent risks identified herein, and those risks not specifically identified. My participation in this activity is purely voluntary; no one is forcing me to participate, and I elect to participate in spite of the inherent risks.

I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. I acknowledge that the staff of Wilderness River Adventures has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. Therefore, I assume full responsibility for myself, including all minor children in my care, custody and control, for bodily injury, death, loss of personal property, and expenses thereof as a result of those inherent risks and dangers identified here in and those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity.
